

## Nikkei Online Edition - For Corporate Use Terms and Conditions of License Sales

### Article 1 (Purpose of Terms and Conditions)

1. These Terms and Conditions set forth in this Agreement apply to all transactions (hereinafter referred to as "Transaction") that Nikkei China (Hong Kong) Ltd. (hereinafter referred to "Company") provides a customer (hereinafter referred to as "Customer") with licenses (hereinafter referred to as "License") to use Corporate Services, such as Nikkei Online Edition Pro (hereinafter referred to as "Service"). This Service shall be provided by Nikkei Inc. (hereinafter referred to as "Nikkei").
2. Customer shall be limited to a corporation or an organization having its head office in the country and area listed in Item 2 of Exhibit.
3. These Terms and Conditions shall apply to each individual transaction between Company and Customer (hereinafter referred to as "Individual Contract") in common. Specific terms and conditions in each Transaction, such as the type of the Service, the Service plan, and the starting date of use of the Service, are set forth in each Individual Contract.
4. ["Nikkei Online Edition \(For Corporate use\) Terms of Use"](#) stipulated by Nikkei (hereinafter referred to as "Terms of Use") shall apply to the use of the Service. Customer is required to agree to the Terms of Use in purchasing the License.
5. In the case where there is any discrepancy in the content provisions among Individual Contract(s), these Terms and Conditions and the Terms of Use, the provisions shall prevail in this order.
6. Time and date contained in these Terms and Conditions shall all be based on Japan Standard Time.

### Article 2 (Conclusion of Individual Contract)

1. Company shall provide Customer with the License of the Service in accordance with the Four (4) Service plans (Personal, Team, Standard, Enterprise). The contents and the conditions of the Service are as per Item 1 of Exhibit. Customer who uses either Team or Standard and applies for ③、⑥、⑦、⑧、⑨、⑩、⑪、⑫、⑬、⑭ in Item 1 of Exhibit (4) is subject to multiple plans.
2. Customer shall apply for the License specifying the Service plan by means of the Application Form designated by Company (hereinafter referred to "Application Form").
3. Individual Contract shall come into effect upon Company's accepting the application in the preceding paragraph and notifying with a written notice, such as e-mail to Customer.
4. The starting date of Service, payment method and due date shall be determined by consultation between Company and Customer after establishment of individual contract. After Contract established set forth in the preceding paragraph, Company will contact the person in charge on the Application Form.

5. The initial date for reckoning the Service Term shall be the first day of the following month unless the chosen date is the first day of the month. If it is the case, Customer can use the Service free of charge for the rest of the month.

#### Article 3 Changes and Cancellation of Individual Contract

1. Customer shall not cancel the individual contract during the Service Term.
2. Customer shall have the right to change the plan only when the service fee is increased during the Service Term. Upon change of the plan, customer shall pay for the balance.
3. Upon the expiration of the initial Service Term, this Individual Contract shall automatically renew for successive period of one year. The monthly fee of the Service plan may modify annually, and Company shall subject to thirty (30) days prior notice to Customer. Customer is entitled to cancel Individual Contract yet has to cancel by 20th of the expiration month. Should Customer fail to cancel within this timeframe, Customer will be deemed to have accepted the modified Service pricing for the following Term.
4. Change of Conditions of Individual Contract, Change of Plan, Reduction of Licenses or Cancellation: In the event that Customer changes Conditions or plan, reduces Licenses, or cancels Individual Contract, Customer shall choose the option by 20th of the expiration month of Individual Contract. New change shall be effective as the new Service Term shall commence.
5. Effect of Expiration or Termination of the Service Order due to Company's circumstances. Service Term may be disconnected, and Termination of Agreement shall be immediately affected. Customer shall have the right to get reimbursed the remaining period of contract.

#### Article 4 (Payment of Fees)

1. The fee for the License shall accrue from the initial date of the Service Term pursuant to Clause 5 of Article 2.
2. The fee shall be prepaid annually in principle, but not include daily payment.
3. Customer shall pay for the service without delay in accordance with the Application Form.
4. Any undisputed payment not made when due will be subject to a late charge with interest of 14.6% per annum.
5. Company shall modify the License fee listed in Item 1 of Exhibit with an advance written notice (including electronic mail) to Customer. The new fee shall be in effect on the initial date of renewed contract.

#### Article 5 (Service Support)

1. Company shall provide Customer with efficient support to use the Services. Please contact us for any inquiries for the Services.

2. Company shall receive and relay any inquiries as to newspaper articles and content in the Services to Nikkei.

#### Article 6 (Termination of Agreement)

Company may terminate Individual Contract in case of the following causes.

1. If Customer is in breach of Terms and Conditions, Individual Contract, and/or Service regulations, and fails to correct such breach within a given time frame;
2. If Customer is in breach of a payment obligation, and fails to correct such breach;
3. If Customer has been in loss of contact for a long time as well as no sign of use of License;
4. If Customer shall be acknowledged amid the financial crisis, such as bankruptcy proceedings, civil rehabilitation proceedings, or company reorganization filings;
5. If Customer shall be dissolved or liquidated;
6. If Customer is liable to any punitive conducts, such as obstruction of business and/or intentional act of defamation of Company and/or Nikkei;
7. Others. If Customer leads a gravely serious cause and Company regards it impossible to maintain the Contract;

#### Article 7 (Trial Use of Service)

1. Company shall provide the License of free trial for 1 (one) month in principle to Customer who applies to use the Services.
2. Such trial services shall be limited to one time per each type of the Services.

#### Article 8 (Confidentiality)

1. All confidential information shall be kept only between Company and Customer and shall not be disclosed to a third party.
2. All confidential information shall be used only for the purpose of the contract between Company and Customer.
3. All confidential information shall remain confidential even after the contract is expired.

#### Article 9 (Management of Personal Information)

Customer's personal information obtained by Company through the Transaction shall be handled in accordance with the [Nikkei Online Edition \(For Corporate use\) Privacy Policy](#).

#### Article 10 (Liability for Damages)

In the event that either Company or Customer causes damages in relation to Transaction, the receiving party of the damages shall claim compensation for the damage in the realm of causal recognition.

#### Article 11 (Exclusion of Antisocial Force)

Company and Customer shall assure that both parties are not anti-social force, uninvolved with anti-social force, unintended to use anti-social force, or unintended to inflict or threaten to damage the other party's business. In addition, any business executives, including representative, officers, and whoever has the substantial management rights shall assure not to be members of anti-social force.

#### Article 12 (Prohibited Matters)

1. Company or Customer shall not transfer the Terms and Condition, its own contractual status, or rights and duty pertaining to above to the third party without the other party's written consent.
2. Customer shall not transfer, sublease, or pawn the License(s).

#### Article 13 (Governing Law and Jurisdiction)

These Terms and Conditions and Individual Contract shall be governed by and construed in accordance with the laws of Hong Kong Special Administrative Region of the People's Republic of China, and the judiciary of Hong Kong shall be the court of jurisdiction for any dispute relating to these Terms and Conditions and Individual Contract.

#### Article 14 (Modification of Terms and Conditions)

Company may revise these Terms and Conditions as needed. Company shall notify Customer in advance if such changes in revision is adverse to Customer. The revised Terms and Conditions shall apply to all Individual Contracts that remain at the time of revision.

#### Article 15 (Language)

These Terms and Conditions are made in Japanese and translated into English. The Japanese text is the original and the English text is for reference purposes. If there is any conflict or inconsistency between these two texts, the Japanese text shall prevail.

The following Articles of these Terms of Use shall apply to the Customers' usage of the Nikkei BP Service, provided, however, that the term "Nikkei" in the following Articles shall be deemed to be appropriately

replaced with "Nikkei or Nikkei BP". Nikkei BP may add to, revise, decrease or otherwise change the scope of the Nikkei BP Service at any time, except for the fee per License. Nikkei may provide Customers' information on Use Contract (names of corporations/organizations, departments, and Service to Use only) to Nikkei BP. Nikkei BP may use the information for responding to Customers' inquiries or other requests.
